BAC Resolution Recommending Procurement thru Negotiated Mode under Lease of Property and Venue, Declaring Lowest Calculated and Responsive Quotation and Recommending Award

WHEREAS, the CONG. SIMEON G. TORIBIO MEMORIAL HOSPITAL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-300 re: PROCUREMENT OF VENUE, ACCOMMODATION, MEALS AND SNACKS AND HOTEL ACCOMMODATION FOR THE PARTICIPANTS OF THE CSGTMH MID-YEAR ASSESSMENT AND STRATEGIC PLANNING with an ABC of ₱ 220, 000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement thru Lease of Property and Venue showed that IWH BOHOL RESORT CORP./ BEST WESTERN PLUS THE IVY WALL RESORT PANGLAO offered the lowest price quotations among the suppliers as reflected in the Abstract of Bids Proposals;



NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:




