WHEREAS, the **BIDS AND AWARDS COMMITTEE** passed BAC Resolution No. 22-0254 series of 2018 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **CENTER FOR DRUG EDUCATION & COUNSELLING, DAO DISTRICT, TAGBILARAN CITY** in undertaking Procurement Request under **PR No. – PHO – 2022 – 050** re: **PROCUREMENT OF FUEL (DIESEL), LUBRICANTS & MAINTENANCE** with an ABC of **P 199,980.00**;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **BOHOL JL DISTRIBUTION SYSTEM, INC.**, offered the lowest price among the suppliers as reflected in the Abstract of Bid Proposals;



- c. To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.




