BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH AGENCY TO AGENCY MODE, DECLARING SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the **CLARIN COMMUNITY HOSPITAL, CLARIN, BOHOL** of the **PROVINCIAL GOVERNMENT OF BOHOL** has requested procurement under **PR No. – PHO – 2022 - 258** re: **PROCUREMENT OF EXPANDED NEWBORN SCREENING KITS with** an ABC of P **87,500.00**;

WHEREAS, in obtaining the above requisitioned goods and considering the urgency of the same, the **PMO/End User** was duly accorded the approval of the Honorable Governor to undertake the procurement request thru an applicable Alternative Mode of Procurement;

WHEREAS, considering that the intended goods can be procured only from a Government Agency, the Negotiated Mode of Procurement through Agency to Agency under Sec. 53.5 of Implementing Rules and regulations of R.A. 9184 has been approved; and

WHEREAS, after canvass of prices done in the course of Negotiated Mode of Procurement, it showed that the **NEWBORN SCREENING CENTER – CENTRAL VISAYAS** is the only bidder which quoted a price within the ABC and with correct specifications or responsive quotation;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED

- a). To allow the use of the Negotiated mode of Procurement through **AGENCY TO AGENCY** in the acquisition of the aforesaid goods;
- b). To declare the **NEWBORN SCREENING CENTER – CENTRAL VISAYAS** as the single responsive supplier and award the procurement of the aforementioned goods to the supplier under **Negotiated Canvass No. – PHO – 2022 – 157 (Agency to Agency)** in the amount of P **87,500.00**;
- c). To recommend approval to the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
