WHEREAS, the Chief of the PRES. CARLOS P. GARCIA MUNICIPAL HOSPITAL, PRES. GARCIA, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of the goods under Purchase Request No. - PHO – 2022 - 255 re: PROCUREMENT OF LABORATORY SUPPLIES with an ABC of P 343,530.00;
