BAC RESOLUTION DECLARING SCRQ THROUGH NEGOTIATED MODE OF PROCUREMENT – EMERGENCY CASES AND RECOMMENDING AWARD

WHEREAS, the TEODORO B. GALAGAR DISTRICT HOSPITAL, JAGNA, BOHOL of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **PHO – 2022 – 215** re: **PROCUREMENT OF SURGICAL GLOVES STERILE** with an ABC of **₱ 743,600.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement – Emergency Cases showed that **IDS MEDICAL SYSTEMS PHILIPPINES, INC.** offered the single price quotation as reflected in the Abstract of Bids Proposals;
