BAC RESOLUTION DECLARING SCRQ THROUGH NEGOTIATED MODE OF PROCUREMENT – EMERGENCY CASES AND RECOMMENDING AWARD

WHEREAS, the TEODORO B. GALAGAR DISTRICT HOSPITAL, JAGNA, BOHOL of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. PHO – 2022 – 217 re: PROCUREMENT OF MEDICAL SUPPLIES with an ABC of ₱ 713,100.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement – Emergency Cases showed that 5JP'S CORPORATION offered the single price quotation as reflected in the Abstract of Bids Proposals;
