WHEREAS, the Chief of the MARIBOJOC COMMUNITY HOSPITAL, MARIBOJOC, BOHOL , of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of the goods under Purchase Request No. - PHO – 2022 - 249 re: PROCUREMENT OF LABORATORY SUPPLIES with an ABC of P 148,510.00;
