BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the GARCIA MEMORIAL PROVINCIAL HOSPITAL, TALIBON, BOHOL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO – 2022 – 252 re: PROCUREMENT OF MATERIALS FOR THE ELECTRIC SERVICE DROP CONNECTION FOR THE LABORATORY with an ABC of P 74,426.00.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that NODAL ELECTRIC TRADE AND SERVICES, offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of NODAL ELECTRIC TRADE AND SERVICES, including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid NODAL ELECTRIC TRADE AND SERVICES, has been found to be ELIGIBLE and its bid, RESPONSIVE;

- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings
