



**BAC RECOMMENDING PROCUREMENT THRU NEGOTIATED METHOD RESULTING FROM THE SECOND FAILURE OF BIDDING, DECLARING LCRO AND RECOMMENDING APPROVAL**

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. \_\_\_\_\_ series of 2018 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY in undertaking Procurement Request under PR No. - PHO - 2022 - 170 re: PROCUREMENT OF DRUG TESTING KITS W/ POLYETHYLENE BOTTLES with an ABC of P 210,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that RUEN GONZAGA MARKETING & DEVELOPMENT, INC. offered the lowest price among the suppliers as reflected in the Abstract of Bid Proposals;
