WHEREAS, the Chief of the GARCIA MEMORIAL PROVINCIAL HOSPITAL, TALIBON, BOHOL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of the goods under Purchase Request No. - PHO – 2022 – 137 re: PROCUREMENT OF GTCB3 BOARD ASSEMBLY & LABOR FOR PART REPLACEMENT with an ABC of P 278,720.28;
