**BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE,
 DECLARING LOWEST CALCULATED AND RESPOSIVE QUOTATION AND RECOMMENDING APPROVAL**

WHEREAS, the GARCIA MEMORIAL PROVINCIAL HOSPITAL, TALIBON, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2022 - 128 re: PROCUREMENT OF HARDWARE MATERIALS AND SUPPLIES FOR GMPH BUILDING REPAIR AND MAINTENANCE FOR STOCK PURPOSES with an ABC of P 393,340.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BQ BUILDERWARE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of BQ BUILDERWARE including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid BQ BUILDERWARE has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare BQ BUILDERWARE as the bidder with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** in the amount P 196,961.15 for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. - PHO - 2022 - 064; while items no. 7, 8, 9, 10, 11, 12, 13, 21, 23 & 24 having no quotation from the suppliers are recommended for re - canvass.
- b.) To recommend award to BQ BUILDERWARE in the amount of **ONE HUNDRED NINETY SIX THOUSAND NINE HUNDRED SIXTY ONE PESOS 15/100 (P 196,961.15)** for the delivery of goods under Negotiated Canvass No. - PHO - 2022 - 064;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings
