**BAC Resolution Declaring SCRQ through Negotiated Mode of Procurement – Emergency Cases and Recommending Award**

**WHEREAS**, the GARCIA MEMORIAL PROVINCIAL HOSPITAL, TALIBON, BOHOL of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **PHO – 2022 – 193** re: PROCUREMENT OF MEDICAL SUPPLIES with an ABC of **P 4,082,000.00;**

**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement – Emergency Cases showed that ASPEN MULTI SYSTEM CORPORATION. offered the single price quotation as reflected in the Abstract of Bids Proposals;

- b). To recommend award to ASPEN MULTI SYSTEM CORPORATION. For the delivery of goods of the aforementioned request for items no. 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 13, 14 & 15 in the amount of **P 4,066,000.00;**
- c). To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
