BAC Resolution Declaring SCRQ through Negotiated Mode of Procurement – Emergency Cases and Recommending Award

RESOLUTION NO. <u>12-</u>0727 Series of 2022

WHEREAS, the GARCIA MEMORIAL PROVINCIAL HOSPITAL, TALIBON, BOHOL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. PHO – 2022 – 193 re: PROCUREMENT OF MEDICAL SUPPLIES with an ABC of P4,082,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement – Emergency Cases showed that <u>ASPEN MULTI SYSTEM CORPORATION</u>. offered the single price quotation as reflected in the Abstract of Bids Proposals;

WHEREAS, pursuant to Section 53.2 of the Implementing Rules and Regulations of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of ASPEN MULTI SYSTEM CORPORATION. Including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, ASPEN MULTI SYSTEM CORPORATION. has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a). To declare ASPEN MULTI SYSTEM CORPORATION. as the bidder with the SINGLE CALCULATED AND RESPONSIVE QUOTATION for the DELIVERY OF GOODS under Negotiated Canvass No. PHO 2022-109 (Emergency Cases); except for items no. 11 & 12 having no quotation from the supplier are recommended for re-canvass.
- b). To recommend award to <u>ASPEN MULTI</u> <u>SYSTEM CORPORATION</u>. For the delivery of goods of the aforementioned request for items no. 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 13, 14 & 15 in the amount of <u>P 4,066,000.00</u>;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
