BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the <u>PROVINCIAL HUMAN RESOURCE MANAGEMENT AND DEVELOPMENT OFFICE</u> of the <u>PROVINCIAL</u> GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-267 re: <u>PROCUREMENT OF CATERING SERVICES FOR THE ORIENTATION OF PGBH NEW ENTRANTS</u> with an ABC of <u>P71,250.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>PANDA TEA GARDEN</u> <u>SUITES</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;

WHEREAS, pursuant to Section 53.9 of the Implementing Rules and Regulations of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>PANDA TEA GARDEN SUITES</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, <u>PANDA TEA GARDEN SUITES</u> has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

- b). To recommend award to <u>PANDA TEA GARDEN SUITES</u> for the Catering Services of the aforementioned request in the amount of <u>P 71,100.00</u>;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
