BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the PROVINCIAL HUMAN RESOURCE MANAGEMENT AND DEVELOPMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. **2022-C-267** re: PROCUREMENT OF CATERING SERVICES FOR THE ORIENTATION OF PGBH NEW ENTRANTS with an ABC of **₱71,250.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PANDA TEA GARDEN SUITES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
