**BAC RESOLUTION RECOMMENDING THE USE OF ALTERNATIVE MODE OF THROUGH DIRECT CONTRACTING,
DECLARING SOLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL**

WHEREAS, the PROVINCIAL MOTOR POOL OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of the goods under Purchase Request No. 2022-0486 re: Procurement of Spare Parts for Road Rollers RR-01 and 105, by the Provincial Motor Pool Office, New Capitol Compound, Tagbilaran City, Bohol. with an ABC of P 332,848.00;

WHEREAS, above requisitioned goods are sold/distributed/provided by CIVIC MERCHANDISING INC. as the sole distributor, of the aforementioned brand of products;
