BAC RESOLUTION RECOMMENDING THE USE OF ALTERNATIVE MODE OF PROCUREMENT THROUGH DIRECT CONTRACTING, DECLARING SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the **PROVINCIAL MOTOR POOL OFFICE** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of the goods under Purchase Request No. **2022-0514** re: Procurement of Spare Parts for Road Rollers RR-03, Volvo with an ABC of P181,865.00

WHEREAS, above requisitioned goods are sold/distributed/provided by **CIVIC MERCHANDISING INC.**, sole distributor, of the aforementioned brand of products;
