WHEREAS, the PROVINCIAL MOTOR POOL OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of the goods under Purchase Request No. 2022-0514 re: Procurement of Spare Parts for Road Rollers RR-03, Volvo with an ABC of P181,865.00
