BAC RESOLUTION RECOMMENDING THE USE OF ALTERNATIVE MODE OF PROCUREMENT THROUGH DIRECT CONTRACTING, DECLARING SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the **PROVINCIAL MOTOR POOL OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of the goods under Purchase Request No. 2022-0525, re: Procurement of Spare Parts for Heavy Equipment with an ABC of P 245,680.00,
