WHEREAS, the <u>PROVINCIAL MOTOR POOL OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of the goods under Purchase Request No. <u>2022-0525</u>, re: <u>Procurement of Spare Parts for Heavy Equipment</u> with an ABC of **P 245,680.00**
