BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the **PROVINCIAL PLANNING AND DEVELOPMENT OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-292** re: **PROVISION OF MEALS, SNACKS AND VENUE FOR THE REGIONAL DEVELOPMENT COUNCIL (PDC) FULL COUNCIL MEETING** with an ABC of **₱ 135, 000.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC.** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
