**BAC Resolution Declaring LCRQ and Recommending Award**

WHEREAS, the SANGGUNIANG PANLALAWIGAN of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-352** re: PROCUREMENT OF MEALS AND SNACKS FOR THE SP EMPLOYEES DURING THE FAMILY DAY 2022 with an ABC of **₱ 95,000.00**;
