WHEREAS, the GOVERNOR'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-251 re: PROCUREMENT OF DINNER RECEPTION FOR VIP'S AND GUESTS with an ABC of P75,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>PANDA TEA GARDEN</u>
