BAC Resolution Recommending Procurement thru Negotiated Mode under Lease of Property and Venue, Declaring Lowest Calculated and Responsive Quotation and Recommending Award

WHEREAS, the <u>GARCIA MEMORIAL PROVINCIAL HOSPITAL</u> of the <u>PROVINCIAL GOVERNMENT OF BOHOL</u> made procurement under Purchase Request No. 2022-C-201 re: <u>PROCUREMENT OF CATERING AND ACCOMMODATION SERVICES FOR THE MID-YEAR ASSESSMENT AND OPERATIONAL PLANNING/ WORKSHOP FOR 2023 with an ABC of <u>P 140, 000.00</u>;</u>

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement thru Lease of Property and Venue showed that <u>PANGLAO BLUEWATER BEACH RESORT, INC.</u> offered the lowest price quotations among the suppliers as reflected in the Abstract of Bids Proposals;

WHEREAS, pursuant to Section 53.10 of the Implementing Rules and Regulations of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of PANGLAO BLUEWATER BEACH RESORT, INC. including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, PANGLAO BLUEWATER BEACH RESORT, INC. has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- b). To recommend award to <u>PANGLAO BLUEWATER BEACH RESORT, INC.</u> for the Catering and Accommodation Services of the aforementioned request in the amount of <u>P 140,000.00</u>;
