BAC RESOLUTION DECLARING LOWEST COMPLYING AND RESPONSIVE BID AND RECOMMENDING APPROVAL

WHEREAS, the **PROVINCIAL GOVERNMENT OF BOHOL** caused the advertisement and posting of Invitation to Bid in the Newspaper, PHILGEPS Website, Provincial Government Website and at three (3) conspicuous places in the premises of the Provincial Capitol Complex, Tagbilaran City of the hereunder project:

WHEREAS, during the opening of bids on **AUGUST 24, 2022**, the following suppliers **5 JP'S CORPORATION & BEROVAN MARKETING, INC.** drop its bid proposal for the said procurement;

WHEREAS, in the detailed evaluation of bids **5 JP'S CORPORATION**, was declared as the Lowest Calculated Bid as Read for item no. 1 in the amount of **P 116,000.00**;

WHEREAS, upon the conduct of post qualification by the Technical Working Group, **5 JP'S CORPORATION**, met the required legal, technical and financial requirements for the said project;

WHEREAS, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by **5 JP'S CORPORATION** the bidder declared as the **LOWEST CALCULATED BID**, successfully passed the Post Qualification process, thus the Committee now considered its bid as the **LOWEST CALCULATED and RESPONSIVE BID** for the said project;

NOW THEREFORE, We the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a.) To declare **5 JP'S CORPORATION** as the **LOWEST CALCULATED and RESPONSIVE BID** for item no. 1 in the amount of **P 116,000.00** for the Procurement of **ECG MACHINE AND MAJOR SURGERY INSTRUMENT SET WITH STERILIZING TRAY** under Project Reference No.- **PHO - 2022 – 090**; while item no. 2 having no quotation from the supplier is recommended rebidding.
- b.) To recommend award to **5 JP'S CORPORATION** in the contract amount of **ONE HUNDRED SIXTEEN THOUSAND PESOS ONLY (P 116,000.00)**;
- c.) To recommend for the approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
