WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2022-0213 series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the BOHOL PROVINCIAL ENVIRONMENT MANAGEMENT OFFICE in undertaking Procurement Request under PR No. 2022-C-058 re: PROCUREMENT OF MEALS FOR THE CAPACITY DEVELOPMENT TRAINING PO/MPA MANAGEMENT COUNCIL ON GIANT CLAMS OCEAN NURSERY MANAGEMENT & MONITORING IN THE PROVINCE with an ABC of P 71, 250.000
