BAC RESOLUTION RECOMMENDING PROCUREMENT THRU NEGOTIATED METHOD RESULTING FROM THE SECOND FAILURE OF BIDDING, DECLARING LCRQ AND RECOMMENDING AWARD

RESOLUTION NO. 22-1450

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-0667 series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by **BOHOL EMPLOYMENT AND PLACEMENT OFFICE – PUBLIC EMPLOYMENT SERVICE OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY** in undertaking Procurement Request under PR No. **2022-0275** re; Procurement of various Ingredients and Kitchenware's for use during the Integrated Livelihood Program of Kabuhayan for ELCAC Beneficiaries with an ABC of **₱1,883,933.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **PRIME E CONSTRUCTION AND SUPPLIES TRADING AND BOHOL QUALITY CORPORATION** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, **PRIME E CONSTRUCTION AND SUPPLIES TRADING AND BOHOL QUALITY CORPORATION** has been found to be **ELIGIBLE** and its quotation, **RESPONSIVE**;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVES**, as it is hereby **RESOLVED**:

- a). - b). To recommend award to **PRIME E CONSTRUCTION AND SUPPLIES TRADING** for delivery of goods/services in the amount of **₱ 1,159,328.00** and to **BOHOL QUALITY CORPORATION** for the delivery of goods/services also, in the amount of **₱ 451,831.10**, under Negotiated Canvass No. **2022-0393 (Failure)**;
- c). To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
