WHEREAS, the **BIDS AND AWARDS COMMITTEE** passed BAC Resolution No. 2022-325 series of 2018 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **FRANCISCO DAGOHOY MUNICIPAL HOSPITAL, INABANGA, BOHOL** in undertaking Procurement Request under **PR No. – PHO – 2022 – 164** re: Procurement of Emergency Crash Cart/Trolley, Wheeled Stretcher, Laryngoscope Examination Table with Stirrup and Doppler Apparatus with an ABC of **P 358,400.00**;




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- c. To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.




