
WHEREAS, canvass of prices done in the course of the Negotiated Method of showed that **REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC., PANDA TEA GARDEN SUITES** and **ALTA CEBU VILLAGE GARDEN RESORT, INC.** have the same price quotations as reflected in the Abstract of Bid Proposals, a toss coin was made to break the tie declaring **REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC.** as the winning bidder;
