DECLARING LOWEST CALCULATED AND RESPOSIVE QUOTATION AND RECOMMENDING APPROVAL**

WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL SITE COGON DISTRICT, TAGBILARAN CITY, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2022 - 069 re: PROCUREMENT OF OFFICE SUPPLIES for the National AIDS & STI Prevention & Control Program with an ABC of P 51,998.00;






NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


- a.) To declare PRIM E CONSTRUCTION SUPPLIES TRADING as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION in the amount P 51,952.60 for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. - PHO - 2022 - 028;
- b.) To recommend award to PRIM E CONSTRUCTION SUPPLIES TRADING in the amount of FIFTY ONE THOUSAND NINE HUNDRED FIFTY TWO PESOS AND 60/100 (P 51,952.60) for the delivery of goods under Negotiated Canvass No. - PHO - 2022 - 028;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings


