BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPOSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL SITE COGON DISTRICT, TAGBILARAN CITY, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2022 -∠069 re: PROCUREMENT OF OFFICE SUPPLIES for the National AIDS & STI Prevention & Control Program with an ABC. of P 51,998.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PRIM E CONSTRUCTION SUPPLIES TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of PRIM E CONSTRUCTION SUPPLIES TRADING including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid PRIM **E CONSTRACTION SUPPLIES TRADING** has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

To declare PRIM E CONSTRUCTION SUPPLIES TRADING as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION in the amount P 51,952.60 for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. - PHO - 2022 - 028;

To recommend award to PRIM E CONSTRUCTION SUPPLIES TRADING in the amount of FIFTY ONE b.) THOUSAND NINE HUNDRED FIFTY TWO PESOS AND 60/100 (P 51,952.60) for the delivery of goods under Negotiated Canvass No. - PHO - 2022 - 028;
