**BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THOROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL**

WHEREAS, the OFFICE OF BOARD MEMBER ROMULO G. CEPEDOZA, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0298, re; Procurement of VEHICLE SPARE PARTS WITH LABOR FOR THE SERVICE VEHICLE MITSUBISHI/STRADA WITH PLATE NO. SKY - 356, with an ABC of P 87,890.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that TAGBILARAN CITY TYRE SALES AND SERVICE CENTER offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:






