BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THORUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the OFFICE OF BOARD MEMBER ROMULO G. CEPEDOZA, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0298 re; Procurement of VEHICLE SPARE PARTS WITH LABOR FOR THE SERVICE VEHICLE MITSUBISHI/STRADA WITH PLATE NO. SKY - 356, with an ABC of P 87,890.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that TAGBILARAN CITY TYRE SALES AND SERVICE CENTER offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of TAGBILARAN CITY TYRE SALES AND SERVICE CENTER including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation TAGBILARAN CITY TYRE SALES AND SERVICE CENTER has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVED:

- To declare TAGBILARAN CITY TYRE SALES AND SERVICE CENTER as the supplier with the LOWEST CALCULATED AND a.) RESPONSIVE QUOTATION for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. 2022 - 0298;
- To recommend award to TAGBILARAN CITY TYRE SALES AND SERVICE CENTER for the delivery of goods/services under b.) Negotiated Canvass No. 2022 - 0298 in the amount of P 87,817.00;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
