WHEREAS, the PROVINCIAL COOPERATIVE DEVELOPMENT OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022 - 0580 re; Purchase of Unleaded Gasoline & Lubricants with an ABC of P 200,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL PROVINCIAL EMPLOYEES -MULTI-PURPOSE COOPERATIVE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
