**WHEREAS**, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-0675 series of 2022 re: Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by Honorable Governor, authorizing the use of the such Method of Procurement by PROVINCIAL ADMINISTRATOR'S OFFICE undertaking Procurement Request under PR No. 2022-0276; Procurement of Laptop, by the Provincial Administrator's Office, Capitol Compound, Tagbilaran City, Bohol. with an ABC of ₱ 150,000.00;

**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement showed that B AND J COMPUTER SALES AND ELECTRONIC SERVICES INC offered the lowest price quotation among the suppliers as reflected i Abstract of Bid Quotation;
