WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2017 series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by OFFICE OF THE PROVINCIAL AGRICULTURIST. in undertaking Procurement Request under PR No. 2022-0130; Procurement of Insecticide (Lannate), by the Office of the Provincial Agriculturist, New Capitol Compound, Tagbilaran City. with an ABC of 144,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>LEZAR TRADING</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, LEZAR TRADING has been found to be ELIGIBLE and its quotation, RESPONSIVE;
