BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the OFFICE OF THE GOVERNOR, NEW CAPITOL BUILDING, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022 - 0589 re; Purchase of Tires, Battery, Oil and Lubricants for the service vehicle used at Governor's Office with plate no. SJC - 371 Isuzu crosswind with an ABC of P92,137.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that NORTHWAY TYRE CENTRE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
