WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-0371-A series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by Office of the Provincial Agriculturist in undertaking Procurement Request under PR No. 2022-0267; Procurement of Furniture & Fixture for the Improvement of Farm Machinery Office in BOATECH, by the Office of the Provincial Agriculturist, New Capitol Compound, Tagbilaran City. with an ABC of P250,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PRIM E CONSTRUCTION SUPPLIES TRADING, offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid
