WHEREAS, the PROVINCIAL ENGINEER'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2021-0893 re: PROCUREMENT OF ANAPOG FOR REGRAVELLING OF CABANBAN BARANGAY ROAD, DIMIAO, BOHOL with an ABC of ₱ 224,500.00;




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:




