WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0329, re; Procurement of Plaques, Frame for Certificates and Streamer by the Office of the Provincial Agriculturist, New Capitol Compound, Tagbilaran City, with an ABC of P 72,639.28;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:






