BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the OFFICE OF THE SP-BOARD MEMBER ELPIDIO L. BONITA, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0358 re; Procurement of Various Office Supplies, Sporting Goods, and House Keeping Supplies, by the Office of Board Member Elpidio L. Bonita, New Capitol Compound, Tagbilaran City. with an ABC of P 118,422.05.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that DELMA ENTERPRISE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;






