BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the GARCIA MEMORIAL PROVINCIAL HOSPITAL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-204 re: PROCUREMENT OF CATERING SERVICES FOR THE DIFFERENT ACTIVITIES OF THE GARCIA MEMORIAL PROVINCIAL HOSPITAL with an ABC of ₱ 176, 750.00;
