BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PROVINCIAL GENERAL SERVICES OFFICE**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2022-0416**, re: **Procurement of Epson Ink Cartridges & HP Lazer Jet Ink**, by the **Provincial General Services Office**, **New Capitol Compound, Tagbilaran City** with an ABC of **P 59,050.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **DELMA ENTERPRISE** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **DELMA ENTERPRISE** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation **DELMA ENTERPRISE** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:


- a.) To declare **DELMA ENTERPRISE** as the supplier with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION**, for items no. 1, 2, 3, & 4 in the amount of **FORTY SEVEN THOUSAND EIGHT HUNDRED TWELVE PESOS AND 50/100 (P 47,812.50)** for the **DELIVERY OF GOODS/SERVICES** while item no. 5 having no quotation from the supplier is recommended for **petty cash** under Negotiated Canvass No. **2022-0297**;
- b.) To recommend award to **DELMA ENTERPRISE** for the delivery of goods/services under Negotiated Canvass No. **2022-0297**, in the amount of **P 47,812.50**;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.




