BAC Resolution Declaring LCRQ and Recommending Award

RESOLUTION NO. <u>22-04</u>87 Series of 2022

WHEREAS, the <u>PROVINCIAL HUMAN RESOURCE MANAGEMENT AND DEVELOPMENT OFFICE</u> of the <u>PROVINCIAL GOVERNMENT OF BOHOL</u> made procurement under <u>Purchase Request No. 2022-C-197 re: <u>PROVISION OF CATERING SERVICES DURING THE VALUES ORIENTATION WORKSHOP (VOW)</u> with an ABC of <u>P 240, 000.00</u>;</u>

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>THE BOHOL SHORES</u> offered the lowest price quotations among the suppliers as reflected in the Abstract of Bids Proposals;

WHEREAS, pursuant to Section 53.9 of the Implementing Rules and Regulations of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of THE BOHOL SHORES including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, THE BOHOL SHORES has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a). To declare <u>THE BOHOL SHORES</u> as the bidder with the <u>LOWEST CALCULATED AND RESPONSIVE</u> <u>QUOTATIONS</u> for the <u>CATERING AND ACCOMMODATION SERVICES</u> under Negotiated Canvass No. <u>2022-</u>
- b). To recommend award to <u>THE BOHOL SHORES</u> for the Catering and Accommodation Services of the aforementioned request in the amount of <u>P 235,000.00</u>;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
