WHEREAS, the **PROVINCIAL HUMAN RESOURCE MANAGEMENT AND DEVELOPMENT OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. 2022-C-197 re: **PROVISION OF CATERING SERVICES DURING THE VALUES ORIENTATION WORKSHOP (VOW)** with an ABC of **P 240,000.00**;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **THE BOHOL SHORES** offered the lowest price quotations among the suppliers as reflected in the Abstract of Bids Proposals;


