WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-0501 series of 2022 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the BOHOL PROVINCIAL ENVIRONMENT MANAGEMENT OFFICE in undertaking Procurement Request under PR No. 2022-C-128 re: PROCUREMENT OF CATERING SERVICES FOR THE UPDATING OF ESWM IMPLEMENTATION PER LGU; IEC ACTIVITY ON ENVIRONMENTAL PROTECTION AND MANAGEMENT PROGRAM with an ABC of P 750, 975.00;

WHEREAS, canvass of prices done in the course of the **Negotiated Method** of showed that <u>**REYNA'S THE HAVEN**</u> <u>**AND GARDENS FOOD CATERING SERVICES, INC.**</u> offered the lowest price quotations among the suppliers as reflected in the Abstract of Bids Proposals;
