BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the <u>BOHOL EMPLOYMENT & PLACEMENT OFFICE</u> of the <u>PROVINCIAL GOVERNMENT OF BOHOL</u> made procurement under Purchase Request No. 2022-C-202 re: <u>PROVISION OF MEALS AND SNACKS FOR THE STRENGTHENING PGBH-BAPESOM PARTNERSHIP</u> with an ABC of <u>P 75, 000.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>REYNA'S THE HAVEN</u>
