WHEREAS, the **BOHOL EMPLOYMENT & PLACEMENT OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-202** re: **PROVISION OF MEALS AND SNACKS FOR THE STRENGTHENING PGBH-BAPESOM PARTNERSHIP** with an ABC of **₱ 75,000.00**;
