WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. <u>22-0246-A</u> series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the <u>PROVINCIAL PLANNING AND DEVELOPMENT OFFICE</u> in undertaking Procurement Request under PR No.2022-C-092 re: <u>PROCUREMENT OF MEALS, SNACKS AND VENUE FOR THE PROVINCIAL MONITORING AND EVALUATION SYSTEM MEETINGS AND CAPABILITY TRAINING</u> with an ABC of <u>P 149, 600.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of showed that <u>REYNA'S THE HAVEN</u>

<u>AND GARDENS FOOD CATERING SERVICES, INC.</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals;
