**WHEREAS**, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-0247-A series of 2022 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **PROVINCIAL PLANNING DEVELOPMENT OFFICE** in undertaking Procurement Request under PR No. **2022-C-100** re: **PROVISION OF ACCOMMODATION, MEALS, SNACKS AND VENUE FOR THE SUSTAINABLE DEVELOPMENT GOALS (SGDS) MEETING AND OTHER CAPABILITY BUILDING ACTIVITIES/ TRAININGS** with an ABC of **₱ 209,000.00**;




